- 1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
- 2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$451,145
- 3. The total amount of emergency financial aid grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is \$451,145

Attachment A

HEERF FUNDS DISTRIBUTION PROCEDURES

SOCHi compiled a list of all active and LOA students as of the date the funds were received on May 28, 2020.

The scrubbed final list was 251 students including active and loa statuses. The official list with names, addresses, emails and phone numbers is available upon request to the Administrative Dean listed above.

\$451,145 divided by 251 = \$1797.39 will be distributed to each student on the list.

Based on guidelines from DOE that indicate the basic content, a letter was drafted and emailed and texted to students using our software letting them know to expect the checks in approx 7-10 days and with information on what to do if they have a change of address. Adminstration will update the outer envelope with any corrections that come in after the check printing is done.

Any returned or uncashed checks will be compiled and efforts will be made to contact the student and distribute the funds. If a student cannot be reached and funds are not distributed, then those will be set aside for a future student in need who returns from a withdrawal due to COVID from the same time frame as the funds were disbursed. This will be on a case by case basis depending on need and availability of additional funds after all attempts are made to reach the original eligible students.
